### **PRIVACY POLICY**

This Privacy Policy applies to the publications, websites and services operated by Mission Viejo Nadadores Foundation ("MVNF"), including Dive, Swim, Masters, Swim School and Triathlon ("We" or "Us" or "Our"), accessible via TeamUnify.com, MVNDive.com. and any other online and/or mobile applications or websites operated by (collectively, the "Services").

MVNF is a long-established, approved 501c3 non-profit which since 1971 has provided aquatic services in Southern California to many thousands of individuals. Nadadores' accomplishments have ranged from learning basic water safety and learning to swim, to numerous Olympic gold medalists and world champions.

This Policy, together with any other documents referred to in this policy, sets out how we may or will use any personal information which you provide to us. Please read it carefully before you proceed. By visiting MVNF services, and/or using the services offered, you acknowledge you agree to the terms of this Privacy Policy, and as it may be amended from time to time. This Privacy Policy is incorporated into, and part of, the terms and conditions of our services.

Please note carefully that while MVNF makes every reasonable effort to protect and insure the privacy of your information, in this era in which virtually every organization is online and hackers seek constantly to acquire private information, despite our best efforts your information may become known in whole or in part. For example, you might pay by credit card and MVNF may do a superb job of protecting that information yet the credit card company or bank may be hacked and your information may be therefore exposed.

### **INFORMATION WE COLLECT**

Information you provide us:

- For an individual user when you register for a program, we collect, at a minimum, your email address, a password, your mailing address, phone number and your name. Depending on how you use the Services, we may also collect your credit card(s)
- Contact information such as address and phone number of athletes and family members;

- Team member information, including where applicable information about your children;
- Messages and chat you send via the services;
- Team information, such as rosters, schedules, attendance, statistics, and scores;
- Activity information you upload, including photos, news, information and other content;
- Payment information;
- Survey responses and feedback, or information when you enter a competition or promotion sponsored by Us, sign-up for email newsletters and when you report a problem with the Services. You can choose not to provide us with some of this information, but doing so may affect your ability to use the Services;
- Messages you send to us;
- Transactional information; and,
- We may receive your information from third parties that provide services for us in connection with the Services, and connect this information to your information that we already have.

## **AUTOMATICALLY COLLECTED INFORMATION**

We may also collect information from your electronic device(s) [smartphone, iPad, or other similar devices] when you use the Services, including:

- Details of your visits to our Services including, but not limited to, traffic data, location data, weblogs and other communication data.
- Information about your computer, mobile phone, tablet, and all other similar electronic or mobile devices, including where available your IP address, operating system and browser type, device identifiers, device settings, device attributes, browser settings, the web pages of the Services you have visited, Services visited before and after you visit a Service, and the content and advertisements you have accessed, seen, forwarded and/or clicked-on.
- Information about your general internet usage by using a cookie file which is stored on the hard drive of your computer. Cookies are small pieces of information (e.g., cookies, web beacons, pixels, gifs tags or other similar technologies) sent by a web server to a web browser which allow the web server to recognize the web browser. This operates as a piece of data stored on your browser or device, or may identify, compile, aggregate and/or collect information through other means. They help Us to improve Our Services and to deliver a better and more personalized service. You can control how your browser handles cookies received from websites. You can choose to refuse all cookies, or to be prompted before a cookie is saved to your hard drive, or to only accept cookies from certain website that you designate. Information on deleting or controlling cookies is

available at AboutCookies.org . By refusing to accept cookies from us, you may not be able to use some of the features and functionality available on Our Services.

- **Geolocation Information.** If you are accessing a Service from a mobile device or through a mobile app you may be asked to share your precise (GPS level) geolocation information with us so we can customize your experience on our platform. If you agree to such collection, in most cases, you will be able to turn off such data collection at any time by accessing the privacy settings of your mobile device and/or through the settings in the applicable mobile application.
- **Social Media Information.** You also can engage with the Services through social media services or other third party platforms, such as Facebook, or other third-party social media plug-ins, integrations and applications. ## **HOW WE USE THE INFORMATION**

We use the information we collect in the following ways to provide the Services, including

- responding to your requests or inquiries;
- sending you service-related communications, including announcements and administrative messages;
- displaying certain content, such as content you upload and make available, comments, messages, scores, availability; photos, statistics and rankings. By using our Services you automatically authorize MVNF to take photographs of you, and to use those photographs in any form of written, online or published content including mass media;
- analyzing and improving the Services;
- processing your entries into sweepstakes, contests or promotions.
- For any specific purpose for which it was provided or volunteered.
- To develop, market, sell or provide products and services.
- To provide you with advertising based on your activities and interests;
- To sending you newsletters, surveys and information about products, services and promotions offered by Us or our partners.
- To prevent fraud and defend our legal rights, including to

- protect the safety of our users and others;
- enforce our terms of service; and
- prevent fraud or any other potentially illegal activities.
- To comply with applicable law

## **DISCLOSURE OF INFORMATION**

We may share your information with:

- Service providers that perform certain business-related functions on our behalf: including analytics, website hosting, transaction fulfillment, payment, contest, sweepstakes and promotion administration.
- Advertisers, Advertising Networks, and Other Third Parties: information about how you use the Services and interact with content or ads to better tailor services, products, marketing and advertising on our service or on third party platforms.
- Social Networks: if you use social networks through the services. To control this sharing of information, please review the relevant social network's privacy policy.
- Other Users: depending on how you use the Services your information may be available to other members your league.
- As required by law in with law enforcement agencies or regulators to:
  - protect our legal rights, privacy or safety, and that of our users, or other individuals;
  - protect against fraud or other illegal activity;
  - respond to inquiries or requests from government, law enforcement, or public authorities;
  - comply with the law including with subpoenas, search warrants, court orders, and other legal process; or
  - enforce applicable terms of service.
- National Governing Bodies: We may share your information with the following National Governing Bodies: USA Swimming, USA Diving, United States Olympic and Paralympic Committee, FINA, Southern Pacific Association, AAU, Divemeets.com, and other similar organizations.

## **SPORTS ENGINE**

The Services are powered by SportsEngine, Converge and Host Gator. SportsEngine, Converge and Host Gator collect information from users depending on how they use the Services, as set forth in the NBCUniversal Privacy Policy. For logged in users, SportsEngine, Converge and Host Gator may collect:

- device identifiers and usage data for analytics purposes,
- data related to messages in the SportsEngine, Converge and Host Gator account, and

- volunteer information such as name and email address.
- When administrators are logged in, SportsEngine, Converge and Host Gator may collect:
  - device identifiers and usage data for analytics purposes,
  - data related to messages in the SportsEngine, Converge and Host Gator account,
  - administrator information such as name and email address data, and other relevant information when the administrator connects with SportsEngine, Converge and Host Gator personnel, for instance through the built-in chat feature.
- When users are not logged in to SportsEngine, Converge and Host Gator, SportsEngine, Converge and Host Gator collects device identifiers and usage data for analytics purposes.

## **ADVERTISING AND ONLINE TRACKING**

We may allow third-party companies to serve ads and collect certain information when you access any software. The criteria on which the period will be determined will be 24 months from the data on which the user's account was last accessed. Your information will be retained for as long as is reasonably necessary for the purposes listed above or as required by applicable local law. We may keep an anonymized form of your personal information, which will no longer refer to you, for statistical purposes without time limits, to the extent that we have a legitimate and lawful interest in doing so.

## **YOUR RIGHTS & CHOICES**

- You may unsubscribe at any time from our email newsletters or promotional emails by following the opt-out instructions contained in the email. You cannot unsubscribe from service-related, transactional, or emails.
- You use you may be able to access and correct certain information through the features provided by the Services. In addition, where legally required, we will provide users with access to their information and the ability to review, update, correct, and/or delete it. We will take reasonable steps to verify your identity.

## **PUBLIC AND INTERACTIVE AREAS OF OUR SERVICES**

Personal information that you post on or through the public areas of our Services are generally accessible to, and may be collected and used by, others and may result in unsolicited messages or other contact from others. You should not provide personal information about yourself in public or interactive areas of our Services. Such personal information is not covered under this Privacy and Cookie Policy.

## **CHANGES TO OUR PRIVACY POLICY**

Any changes we may make to our privacy policy in the future will be posted and will be effective upon posting and as reflected in the "Last revised" date shown in the revised policy. Your continued use of our Services after any such changes are posted will be considered agreement to such changes. Under certain circumstances, we may also

elect to have such changes notified to you by e-mail or by posting a notice on the front page of our Services. You should regularly check back to this page from time to time.
